KEY UPDATES FOR OCTOBER 2007:

New Payors:

- Confederated Tribes of Coos, Lower Umpqua, & Siuslaw Indians are a new client of our Oregon PPO, Healthcare Direct, and they will also access FCHN; they are effective June 1, 2007.
- Mountain States Administrative Services is new effective August 1, 2007.

Terminating Payors:

- Physician Hospitals Community Organization (PHCO) terminates December 31, 2007.
- Yakima Valley Farm Workers Clinic terminated August 31, 2007.

Other Updates:

- Alexandria Moulding will change their venue of access to FCHN from a direct relationship to access via Principal Financial Group effective September 1, 2007. Also, FCHN will no longer provide Medical and Case Management for Alexandria Moulding.
- AmeriBen/IEC Group terminated its direct relationship with FCHN effective June 30, 2007, however they remain an active payor under Beech Street.
- Gilsbar, Inc terminates its direct relationship with FCHN effective December 31, 2007, however they remain an active payor under Beech Street.
- Washington-Idaho Operating Engineers Health & Welfare Trust will change their venue of access to FCHN from a direct relationship to access via Zenith Administrators effective September 1, 2007. Zenith's Spokane office will handle the claims administration.
- Zenith Administrators recently acquired Administrative Services Inc (ASI) in Spokane. ASI is the administrator/payor for Hecla Mining Co, Laborers AGC Trust of Montana, and Washington & Idaho Carpenters Health & Security Trust. At this time no changes are required for claims routing or contact information.


